

## NORTH CAROLINA BOARD OF PHOTOGRAPHIC EXAMINERS

The North Carolina State Board of Photographic Examiners was established in 1935 and discontinued in 1949. Apparently the records contained in this group consists of all material created by the board during its fourteen year existence. However, it is possible that some of the records may have been misplaced as there seemed to be no permanent central office. According to Public Laws, 1935, chapter 155, article II, section 5, "The principal office of the Board shall be at such place designated by a majority of the members of the board." All evidence indicates that the locality of the principal office shifted each time a new secretary-treasurer was elected.

These records are filed alphabetically, that is when any system at all is used, with no respect to chronology. They consist of general correspondence which contains two sets of files - one a subject file, in no particular order, and one a general file in very good alphabetical order; there are approximately 350 applications for photographer and two cubic feet of applications for examination for license as photographer filed alphabetically by names with pertinent correspondence from, to, and about the applicant.
