HISTORY AND DESCRIPTION: Papers from four generations of the McCulloh family from whom Lawrence James descended: Henry McCulloh of Cullo, Henry Eustace McCulloh, George McCulloh and W. D. McCulloh. Twenty-two of the folders contain materials relating to the McCulloh lands in North Carolina and relate directly to Henry Eustace McCulloh and to his natural son, George, who was his agent to recover the lands in North Carolina following the Revolutionary War (the lands of Henry Eustace McCulloh being specifically confiscated by name in the confiscation act).
