Fiscal Year 2012-2013

The following is submitted in compliance with Chapter 93B-2 of the General Statutes for the period ending June 30, 2013.

2. 121 persons applied to the Board for the auctioneer examination during the 2012-13 fiscal year.
18 persons applied to the Board for the auction firm examination during the 2012-13 fiscal year.
3. No persons were refused the written examination.
4. 119 persons took the auctioneer examination during the 2012-13 fiscal year.
17 persons took the auction firm examination during the 2012-13 fiscal year.
5. 111 auctioneers were issued initial licenses; 3 apprentice auctioneers were issued initial licenses; and, 30 auction firms were issued initial licenses.
6. 8 persons applied for an auctioneer license by reciprocity or comity.
7. 8 persons were granted licenses by reciprocity or comity.
- 7a. 12 official complaints were received involving licensed and unlicensed activities.

- 7b. 6 disciplinary actions were taken against licensees; 5 non-disciplinary actions were taken against licensees; and 0 non-disciplinary actions were taken against non-licensees.
8. 2 licenses were revoked. 1 license was suspended.
9. 11 licenses were terminated due to death and 12 licenses were permanently retired.
10. At this time, there are no anticipated requests by the North Carolina Auctioneer Licensing Board to the General Assembly to amend statutes related to the Auctioneer Law.
11. At this time there are no anticipated changes in rules adopted by the North Carolina Auctioneer Licensing Board or any anticipated adoption of new rules by the North Carolina Auctioneer Licensing Board.
